### NOTIFICATION TO ALL MEMBERS OF THE NATIONAL ASSEMBLY AND SPECIAL SITTINGS OF THE ASSEMBLY TO BE HELD ON 19 MAY 2021

**PURSUANT** to the provisions of Standing Order 10 of the National Assembly, the Majority Party requested the Speaker to convene the National Assembly to consider specified matters;

**AND THE SPEAKER**, having acceded to the request, has fixed **May 19, 2021** as a day for the Special Sittings of the National Assembly;

**NOW, THEREFORE**, it is hereby notified to all members of the general public that **Wednesday, May 19, 2021** shall be the day for the Special Sittings of the National Assembly. The Special Sittings shall be held in the **Assembly Chamber in the Main Parliament Building** at **10.00 am and at 2.30 pm** (Morning and Afternoon).

- A. Tabling of the Report of the Department of the Environment on the vetting of the nominee for appointment as the Chief Justice of the Republic of Kenya;
- B. Tabling of any other Papers with statutory force;
- C. Transaction of the following business—
  - (i) Notice of Motion and consideration of the Report of the Commission of Inquiry into the appointment of a Chief Justice of the Republic of Kenya;
  - (ii) Consideration of the Reports of the Commission of Inquiry into the following-
